### **GDPR:**

Since May 2018, the storage, retention and use of data collected by all organisations is now subject to additional European regulation generally referred to as GDPR. Highfield RFC process this data for the purpose of administrating our underage teams. Highfield RFC retains this information until your child leaves our underage system or earlier if you request its removal.

The IRFU require some of the information on this form to be added to the national Rugby database (the Clubhouse system) to establish a child's right to play rugby in Ireland. Additionally, age grade teams (Under 13s and older) are required to electronically register each competing team on an online eTeamsheet system. Both the Clubhouse system and the eTeamsheet system are administered by the IRFU. You are entitled to request, directly from the IRFU a copy of all data held on the Clubhouse system and on the electronic team sheet system relating to your child.

### **Data Protection Act:**

It is necessary for Highfield RFC ("the Club") to collect and record certain personal data relating to each

Member, including the member's name, address, telephone numbers, date of birth and school. The data

about each member shall be provided to the IRFU, the relevant Branch and other third parties to facilitate

any services provided relating to the Irish Rugby Football Union's Player Registration Programme Website (The "Website") and published on the Website.

It is the IRFU that controls any data provided. The system will be used for management and administration purposes only. Any party receiving the information shall not use it for commercial purposes or release it to any party without prior approval.

The Club wishes to ensure that each of its members (for the purposes of applicable data protection legislation) explicitly and unambiguously consents to the processing of personal data by the Club in conjunction with its ordinary business. Therefore, the member or, if the member is under 18 years of age,

the member's parent or guardian should confirm the following:

***I consent to the use of the player's personal details as set out above and for such purposes as the IRFU considers reasonable and appropriate (including those activities detailed above).***

**Insurance Cover:** Highfield RFC, its servants, agents or employees are not under any liability whatsoever for the loss of property, accidents or injuries howsoever caused during the course of training, preparation or matches played at Highfield RFC or other grounds. It is the individual's parents/Guardians' responsibility to ensure that their child has adequate insurance cover, general and medical.
